- **PERSONAL DATA PROCESSING PLACE**

The processing operations connected to the data collected will take place at the headquarters of MTA, V.le dell'Industria, no. 12, 26845, Codogno (LO), Italy.

- **CONSEQUENCES OF FAILURE TO PROVIDE DATA**

The provision of personal data is always optional. - **AREA MANAGERS AND AUTHORIZED PERSONAL DATA PROCESSORS**

- **RIGHTS OF THE DATA SUBJECT**

In accordance with the provisions of Chapter III of the GDPR you may exercise the rights indicated therein and in particular:

- **Right of access** - Obtain confirmation as to whether or not personal data concerning you are being processed, and, where that is the case, access to the following information: the purposes of the processing, the categories of personal data concerned and their retention period, the recipients to whom the personal data have been or will be disclosed (article 15, GDPR);
- **Right of rectification** - Obtain without undue delay the rectification of inaccurate personal data concerning you and have incomplete personal data completed (article 16, GDPR);
- **Right of erasure** - Obtain the erasure of personal data concerning you without undue delay, in the cases provided for by GDPR (article 17, GDPR);
- **Right to restriction of processing** - Obtain from all Data Controllers restriction of processing, in the cases provided for by GDPR (article 18, GDPR);
- **Right to data portability** - Receive the personal data concerning you, which you have provided to the Data Controller, in a structured, commonly used and machine-readable format and transmit those data to another data controller, in the cases provided for by GDPR (article 20, GDPR);
- **Right to object** - Object to processing of personal data concerning you, unless the Controller demonstrates compelling legitimate grounds for continuing the processing (article 21, GDPR);

- **Right to lodge a complaint with the supervisory authority** - Lodge a complaint with the Italian supervisory authority (article 77, GDPR), Piazza di Montecitorio no. 121, 00186, Roma (RM), Italy.

The exercise of these rights is subject to certain exceptions aimed at safeguarding the public interest (for example, the prevention or identification of crimes) and our interests. Should you exercise any of the above rights, we will check whether you are entitled to exercise them and we will normally reply to you within one month.

- **NAVIGATION DATA**

Navigation data, the transmission of which is implicit in the use of Internet communication protocols, could by their nature – through association and processing with data held by third parties – allow users to be identified (e.g., IP address; domain names of computers used by users connecting to the website, etc.).

Such data are used by MTA for the sole purpose of obtaining anonymous statistical information on the use of the website and to check its correct functioning and are deleted immediately after processing. Such data could be used to ascertain liability in case of any computer crimes to the detriment of the website and could be shown to the Judicial Authorities, should they explicitly request so.

- **COOKIES**

No personal user data is acquired by the website. We do not use cookies to transmit personal information, nor do we use systems for tracking and identifying users. The use of cookies is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the server) that are necessary to ensure security and efficiency when navigating the website and used for statistical purposes for counting unique monthly visitors. The cookies can be eliminated by the user through the functions of his or her own Internet browser.
